The hearing was presided and called to order by Councilor Jose Edmar J. Yumang to discuss **SPPO NO. 1718-0108: AN ORDINANCE REQUIRING ALL THE TWENTY-SIX (26) BARANGAYS OF GENERAL SANTOS CITY TO CONDUCT AN INTENSIFIED MONTHLY CLEAN UP DRIVE IN THEIR RESPECTIVE TERRITORIAL JURISDICTIONS TO STOP THE RISING THREAT OF DENGUE IN THE CITY OF GENERAL SANTOS CITY, PROVIDING APPROPRIATE ACTION AND FUNDS THEREFOR, AND FOR OTHER PURPOSES.**

Barangay Kagawad Parreñas of Mabuhay informed that they have been conducting a clean-up drive in their barangay and they have a task force in coordination with the Department of Health that closely monitors dengue cases. Per record, they only have a minimal case on dengue. After which, Councilor Acharon suggested to also include the clearing of water base and banana stems in their barangay.

Councilor Bagonoc noting the need of every barangay to come up with its own strategy introduced an amendment by addition that the last sentence of Section 2 be read as: "Each respective barangay council is tasked to formulate its own guidelines for the effective implementation of this ordinance" The chair acting on the motion, duly seconded ruled the same approved, subject to style.

**SECTION 2-APPROVED AS AMENDED, SUBJECT TO STYLE**

Ensuing further deliberations, the chair acting on the motion of Councilor Bagonoc, duly seconded by Councilors Casabuena, Pestaño and Acharon, ruled the ordinance approved on committee level as amended, subject to style to be calendared

for second reading on Tuesday's regular session with the manifestation that Councilors Nuñez, Lagare, Bagonoc, Pestaño, Acharon, Casabuena, and Congson are the co-authors.

There being no more matter to take up, the chair declared the hearing adjourned at 11:08 in the morning.
