The session started with a prayer led by Councilor Lourdes F. Casabuena followed by the singing of the Philippine National Anthem and the General Santos City Hymn by the General Santos City Government Performing Arts Company–Choir Division. The session was then called to order at 9:10 o'clock in the morning with the Honorable Acting Vice-Mayor Elizabeth B. Bagonoc presiding. After the roll was called and there being a quorum, the chair thereupon declared the 46<sup>th</sup> regular session open for business.

**F. READING AND ADOPTION OF MINUTES OF THE 45<sup>TH</sup> REGULAR SESSION:**

On separate motions, Councilor Gacal moved for the dispensation of the reading and adoption of the minutes of the 45<sup>th</sup> regular session duly seconded by Councilors Pacquiao, Acharon, Yumang & Tan. There being no correction manifested, said minutes was then ruled adopted.

**MINUTES OF THE 45<sup>TH</sup> REGULAR SESSION – ADOPTED**

**G. PRIVILEGE HOUR:**

The first speaker was Councilor Lourdes F. Casabuena. After some preliminaries, she took issue of the alarming problem of children in conflict with the law (CICL) or *sukrap*, their proliferation on the streets particularly at night who accordingly were involved in many criminalities citing the recent case of two minors (REYMARK LARGO BAHAY & JOSELITO JADRAQUE DEVIBAR, JR.) and an 18 year old (CHRISTIAN LICO TANIONGON) who were murdered on the eve of June 24, 2017 at Barangay Calumpang, this city. She ended her piece with a challenge to all that something has to be done with this problem. On suspended rules, PO3 Agui of Police Station 5, Barangay Captain Salubre of Calumpang and Ms. Mary Ann Rosaot of CSWDO took turns in responding to queries raised by the councilors relative to the said incident. After further discussion, the honorable speaker concluded saying that in order to address this problem, it needs the collaborative efforts of the government, the community and the family in particular. She then thanked the presence of her resource persons. Suspension of the rules was then lifted.

Second speaker was Councilor Jose Edmar J. Yumang. He took issue of the proliferation of fake news in the social media vis-à-vis Senate Bill No. 1492 entitled "An act penalizing the malicious distribution of false news and other related violations". The spread of bogus information or news poses danger as it impacts the way people interpret and respond to it. Anyone can be subjected to this form of deception that not only offends the orientation of the human intellect to the truth but more fundamentally hinders a person from making right and sound decisions and induces them to make faulty ones. He then concluded that the root cause of fake news spreading widely and quickly is lack of understanding. So, he encouraged everyone to be informed before conforming, deliberate before submitting, analyze before acknowledging, peruse before conceding, and think before clicking or speaking.

On another concern, he presented and expressed congratulations to Mr. Vince Reward Paras who won the WBO Asia Pacific Youth Flyweight title last June 10, 2017 at Mandaue City, Cebu. His trainer (Ramon Vicente) and assistant trainer (Riche Cerillo) were also acknowledged. Photo ops followed.

After her motion for reconsideration was granted, Councilor Rosalita T. Nuñez was recognized as the third speaker. She introduced and made known of another pride of the city in the person of Prof. Reynaldo L. Jope who hails from Barangay Bula, this city, and an alumnus of the Mindanao State University. He is a scholar at Harvard University and a Mathematics teacher in the State of Texas at present. He is also a journalist, an author of two children's books, and has received various awards in almost all fields. After making known of his achievements, the honorable speaker presented a plaque of recognition in his honor as an outstanding citizen of the city for exemplifying the best of General Santos City not only locally but also internationally in the field of education especially in Mathematics, Arts and Literature. On suspended rules, he was given time to share his thoughts, experiences and his plan/project to be of help to the city government by helping the children in particular through his connections. Thereafter, Hon. Nuñez concluded hoping that the life of Prof. Jope will be an example to the people of this city and will continue to inspire the youth. Photo ops followed and suspension of the rules was then lifted. They then proceeded to the next item.
