A prayer led by Councilor Elizabeth Bagonoc along with the General Santos City Performing Arts Choir Division and followed by the community singing of the Philippine National Anthem and the General Santos City Hymn signaled the opening of the session. After thanking the choir, the chair acknowledged the presence of some guests from the DENR and the reigning “*Mutya ng Pilipinas*” SOCSARGEN, Ms. Rachel Valerie Faelden. She also informed the invited guests today to address some concerns in the Q&A - Ms. Geraldine Zamora of the Permits & Licenses, Ms. Grace Mercado of STL Gaming Corporation, City Administrator Atty. Zapatos, Police Sr. Insp. Peter Penalcan, Brgy. Captain Rolito Blando of Lagao and Mr. Bobby Yanzon. She also acknowledged the OJTs from MSU. Thereafter the session was called to order and the roll call followed. There being a quorum, the chair thereupon ruled to proceed to the next business.

F. READING AND ADOPTION OF MINUTES : 46TH REGULAR SESSION

On separate motions of Councilor Bagonoc jointly seconded by Councilors Pacquiao, Acharon, Congson and Casabuena, the reading of the minutes was dispensed with and eventually, it was approved without any correction.

MINUTES OF THE 46TH REGULAR SESSION – ADOPTED

G. PRIVILEGE HOUR:

1. Hon. Elizabeth B. Bagonoc

The first speaker, Councilor Elizabeth Bagonoc when recognized took issue on the different problems and concerns relative to the much talked about climate change where only last month the world celebrated the Environment Month. Despite its theme “Connecting People to Nature”, she said she was devastated to see a tree cut - the last standing tree in G. Mesa St., Brgy. Lagao. Likewise, a video footage was presented showing the familiarization tour and operational orientation conducted by the Solid Waste Management Board and the TWG at the Sanitary Landfill in Brgy. Sinawal. It was said that the operation of the SLF has been hampered due to lack of heavy equipment and yet a number of new heavy equipment delivered in January of this year were left in idle at the compound of the City Engineer’s Office. It was explained later that there were problems with the registration and insurance that has to be complied with by the supplier in which the chair recommends that due damages should be charged to the supplier. The matter was previously referred to the three committees namely, Finance, Climate Change, and Laws.

Further, the same video footage showed the *Linis-Palengke* activities participated by the different committees of this Sangguniang Panlungsod, concerned agencies of this LGU and NGOs. The privileged speaker said she is hoping that the proposed redevelopment of the central public market and the Queen Tuna Park as part of the Integrated Economic Development for Regional Trade in General Santos City will materialize.

At this juncture, Councilor Bagonoc yielded the floor to Forester Benjamin Alangca of DENR XII and under suspended rules, the latter after some preliminaries discussed in detail the Forest Land Use Plan – an agreement undertaking between DENR and LGUs aimed at strengthening the conservation, protection and preservation of environment and natural resources including the financial viability and its eco-tourism side. This FLUP he said, is also required by HLURB in the approval of the Comprehensive Land Use Plan (CLUP). After an exhaustive deliberation on the matter, it was finally agreed that a seminar workshop will be conducted on July 28, 2017, to discuss the FLUP and its policy directions along with the DENR, City Planning and the City Legal Office. It was also informed that in September of this year, the City of General Santos will host the Regional Development Council and a tree planting activity will be held to this effect.

Lastly, Councilor Bagonoc thanked Forester Alangca and informed the body that the latter left a copy of the proposed resolution authorizing the City Mayor Ronnel C. Rivera to enter into a memorandum of agreement with the DENR Region XII, to jointly undertake activities in the formulation, legitimization and implementation of the forest land use plan in the City of General Santos. She said she would be submitted this to the City Vice Mayor. Afterwards, awarding of citation or commendation certificates followed.

2. Hon. Franklin M. Gacal, Jr.

Councilor Gacal introduced to the body the newly crowned “Mutya ng Pilipinas” SOCSARGEN, Ms. Rachel Valerie Faelden and when the latter was given the floor, sought the financial support of the council for her to be able to compete in the national *Mutya ng Pilipinas* to be held in Manila. As to whether or not there was a budget for this, Mr. Cequiña said they can only provide plane tickets for the candidate. Councilor Gacal suggested to check with the CEMCDO on this matter. A photo op with Ms. Faelden followed.
