The session started with a prayer song followed by the singing of the Philippine National Anthem and the General Santos City Hymn by the General Santos City Government Performing Arts Company–Choir Division. The session was then called to order at 9:24 o'clock in the morning with the Honorable City Vice-Mayor Shirlyn L. Bañas-Nogralas presiding. After the roll was called and there being a quorum, the chair thereupon declared the 49th regular session open for business.

F. READING AND ADOPTION OF MINUTES OF THE 48TH REGULAR SESSION:

On separate motions, Councilor Bagonoc moved for the dispensation of the reading and adoption of the minutes of the 48th regular session duly seconded by Councilors Pacquiao, Acharon, Lagare, Llido-Pestaño, Yumang & Casabuena. There being no correction manifested, said minutes was then ruled adopted.

MINUTES OF THE 48TH REGULAR SESSION – ADOPTED

G. PRIVILEGE HOUR:

Before proceeding to the scheduled speakers, Hon. Bañas-Nogralas reminded her colleagues to stick to the one-hour rule intended for the privilege hour as provided in their Internal Rules of Procedure (IRP). She then relinquished the chair to Hon. Bagonoc and availed the privilege hour as the first speaker.

(NOTE: HON. ELIZABETH B. BAGONOC – PRESIDING OFFICER)

When given the floor, Hon. Bañas-Nogralas emphasized the importance of responsible gun ownership vis-à-vis the mandates of the law to safeguard and maintain peace and order in the community. She then introduced and gave way to Police Superintendent Roldan Daniel, the acting chief of the PNP Regional Civil Security Unit XII. On suspended rules, he discussed Republic Act 10591 known as the Comprehensive Firearms and Ammunition Regulation Act of 2013 particularly on the License to Own and Possess Firearms (LTOPF). He informed that by virtue of NAPOLCOM Resolution No. 2016-247 dated April 5, 2016, Regional Civil Security Units (RCSUs) in all police regional offices except the national capital region, are already activated to provide services for firearms registration. After his presentation, he responded to queries raised by the members of the council. He then informed that they are conducting a one-stop shop caravan on LTOPF on August 7, 2017 (8:00 A.M. to

5:00 P.M.) at the Sangguniang Panlungsod Office, this city. Priority applicants are the local government officials including barangay and purok officials. Private individuals are second priority. However, Hon. Bañas-Nogralles emphasized that carrying of firearms will not be allowed inside the SP building during the conduct of said caravan. Further deliberation ensued, thereafter the speaker concluded and thanked the resource person. Corresponding information, schedule and details including the requirements needed will be posted in the electronic board and SP website.

At this juncture, Hon Bagonoc relinquished back the chair to Hon. Bañas-Nogralles.

The second speaker was Councilor Elizabeth B. Bagonoc. After some preliminaries, she introduced and gave way to Mr. Gonzalez of Toxic and Hazard Waste Water Treatment Division of AJAT Philippines, Incorporated. On suspended rules, Mr. Gonzalez presented the Advance Oxidation Process (AOP) as a new sewage treatment technology. He then responded to some queries after his presentation. After further discussion, Hon. Bagonoc thanked the resource person and moved for the resumption of the rules. House rules were then resumed and they proceeded to the next item.
