**SPPR NO. 1718-01118: RESOLUTION AUTHORIZING THE 4<sup>TH</sup> DEGREE KNIGHTS OF COLUMBUS – SARANGANI BAY ASSEMBLY ACN 1770 TO ERECT STATUE OF GAT ANDRES BONIFACIO AT THE PLAZA HENERAL SANTOS.**

After acknowledging everyone's presence, the chair briefed the body that during the first hearing the proponent was required to coordinate with the City Engineer's Office as to the exact location where to establish the statue of GAT Andres Bonifacio in the Plaza Heneral Santos.

Brgy. Captain Ed Castañeda informed that they already had submitted to the City Engineer's Office the required documents like the program of works, the detailed engineering, and the costing. He said they will shoulder all the expenditures, but they need the approval for the establishment of the said statue at Plaza Heneral Santos for the whole SOCSARGEN to celebrate every 30<sup>th</sup> of November the Bonifacio Day here in the city instead of going to Davao City. Thereafter, the chair manifested that Councilor Alberto Pacquiao will be one of the authors.

She then introduced the following amendments:

- to incorporate the phrase "**at its own expense**" in the first whereas, subject to style;
- **4<sup>th</sup> whereas** as an amendment by addition to read as: "**That the Knights of Columbus will be responsible for the maintenance of the statue and its periphery area.**" (subject to style)
- Another amendment by addition: The **last whereas** is to read as: **The Knights of Columbus should make a Memorandum of Agreement with the Local Government of General Santos thru the city mayor**, subject to style.

Thereafter, the chair said the City Engineer's Office will make a design that will blend to the theme of the whole Plaza Heneral Santos and be the one to determine the exact location. After which, she ruled this measure approved to be calendared for second reading on July 4, 2017 regular session.

There being no more matter to take up, the hearing was declared adjourned at 2:24 P.M.
