- In the fourth whereas clause, the word "mythical" was inserted after the word, "tangible"; and
- Section 4 was amended to read as: ENFORCEMENT AND IMPLEMENTATION. The Office of the City Mayor shall promulgate the IRR for the implementation and enforcement of this ordinance.

Upon motion of Honorable Casabuena, duly seconded by Honorable Bagonoc and Honorable Acharon, the chair ruled the ordinance approved on committee level as amended, subject to style and to be calendared for second reading on August 1 regular session with all the councilors present as the co-authors and sponsors.
