Mr. George Tapel after giving a backgrounder said the proposed amendment is just in preparation of any donation from within or outside the city in which the GSC Culture and the Arts Council is a recipient. As there was an emphasis on the main function of the Culture and Arts Council which is only pertaining to performing arts, it would mean that its function is only limited to such aspect since all other cultural aspects were transferred to the heritage and museum. Just like the national government with so many offices, the Congress accordingly passed RA 10066 defining all functions of cultural and arts offices in the provinces which was implemented in the national level. He hoped that the same will be implemented in this city.

Responding to the query of Councilor Bagonoc, Mr. Tapel said it is lawful to create trust fund purposely for grants and endowments as defined in the proposal as to the usage of the money.

Thereafter, as moved and seconded, the chair ruled the same approved on committee level to be calendared on August 1, 2017 regular session for second reading with all the councilors present as the co-authors and sponsors.

There being no more matter to take up, the hearing was declared adjourned at 11:50 A.M.
