WHEREAS, it is enshrined in the 1987 Constitution that all the country's artistic and historic wealth constitutes the cultural treasure of the nation and shall be under the protection of the State, which may regulate its disposition;

WHEREAS, the protection and promotion of the National Cultural Heritage Act of 2009 protects and promotes the nation's cultural heritage, its properties and histories and the ethnicity of local communities;

WHEREAS, Section 16 of the RA 7160, provides that local government unit play an important role in the development, promotion and preservation of Filipino culture and encourage the participation of the people in the development and preservation of Filipino identity;

WHEREAS, General Santos City is actively engaging in the identification and documentation of its distinct natural built, intangible and tangible heritages for the awareness and appreciation of the constituents of their heritage environment, comprehensive development of heritage legislation for protection and conservation, promotion of cultural industries, and development of tourism campaign based on heritage output;

WHEREAS, the city government is currently embarking on its landmark project of establishing the General Santos City Cultural and Heritage Museum;

WHEREAS, there is a need to declare the General Santos City Cultural and Heritage Museum as heritage site in order that it can be protected and conserved;

NOW, THEREFORE, on motion of City Councilor _____ duly seconded by _____, be it-

"AN ORDINANCE DECLARING AS HERITAGE SITE THE GSC CULTURAL AND HERITAGE MUSEUM PROVIDING GUIDELINES FOR ITS PROTECTION AND CONSERVATION AND APPROPRIATING FUNDS THEREFOR"

Be it ordained by the Sangguniang Panlungsod of General Santos City in session assembled, that:

Section 1. Title: This ordinance shall be known as **"AN ORDINANCE DECLARING THE GSC CULTURAL AND HERITAGE MUSEUM AS HERITAGE SITE."**

SECTION 2 - PURPOSES - This Ordinance has for its purposes the following:

1. To officially recognize and declare as heritage site the General Santos City Cultural and Heritage Museum, which is soon to rise in place of the old City Hall building;
2. Promote, protect and conserved said heritage site, recognizing its significance and importance for the preservation of the city's local built and cultural heritages;
3. To develop tourism campaign based on this heritage output;
4. To educate the younger generation of today and the generations to come of a very significant segment of the city's local history;

Section 2. Scope: This ordinance shall apply to the protection, preservation and conservation of the General Santos City Cultural and Heritage Museum;

Section 3. Definition of Terms: For purposes of this Ordinance, the terms enumerated in this Section shall be construed or interpreted to mean or refer to, as follows:

1. **HERITAGE SITE**- is a landmark or area which has been officially recognized and selected on the basis of having cultural, historical, and scientific or some other form of significance.
2. **HERITAGE ZONE**- shall refer to historical, anthropological, archaeological, artistic geographical areas and settings that are culturally significant to the city, as recognized and declared by the city council.
3. **CONSERVATION** - refers to all the processes and measures maintaining the cultural significance of a cultural property including, but not limited to preservation, restoration, reconstruction, protection, adaptation or any combination thereof.
4. **HERITAGE**- is anything of value from the past that gives meaning and identity to the present and that would inspire future generations.
5. **HERITAGE CONSERVATION**- is action taken to sustain the value, meaning and significance of cultural resources from the past for the use of present and inspiration of future generations.
6. **BUILT HERITAGE** - refers to architectural and engineering structure such as, but not limited to, bridges government buildings, houses of ancestry, traditional dwellings quarters, train stations, lighthouse, small ports, educational, technological and industrial complexes, and their settings, and landscapes with notable historical and cultural significance.
7. **CULTURAL HERITAGE** - refers to the totality of cultural property preserved and developed through time and passed on to posterity.

Section 4. ENFORCEMENT AND IMPLEMENTATION. The Office of the City Mayor through the GSC Museum Technical Working Group shall cause the implementation and enforcement this ordinance.

Section 5. Installation of Landmark- For the purposes of recognizing and acknowledging the General Santos City Cultural and Heritage Museum as heritage site, the City government shall install an official landmark within the premises or on the said structure.

Section 6. Allocation of Funds – The City government shall allocate an annual budget that would ensure the effective implementation and enforcement of this ordinance upon its effectivity.

Section 7. Prohibited Act: The intentional act of destroying, demolishing, mutilating or damaging of any structure or features of the above mentioned heritage site is hereby prohibited;

Section 8. Penalty Clause: Without prejudice to the penal provisions of applicable laws, any person, group or corporation found violating any of the provisions of this ordinance or cause the same to be done, shall be liable for a fine of Two Thousand Five Hundred Pesos (P2,500.00) and/or six (6) months imprisonment at the discretion of the court.

Section 9. Separability Clause. The provisions of this Ordinance are separable, and in the event that any or more of such provisions are declared invalid, the validity of all other provisions shall not be affected thereby.

Section 10. Repealing Clause. Any Ordinance, Executive Orders and Local Issuance or Rules and Regulations or part thereof, inconsistent with or in conflict with this Ordinance are hereby repealed and or altered accordingly.

Section 11. Effectivity. This Ordinance shall take effect ten (10) days after its publication in a local newspaper of general circulation within the city.
