RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE RONNEL C. RIVERA TO ENTER INTO A DEED OF QUITCLAIM IN REFERENCE TO THE INCIDENT LAST DECEMBER 16, 2016 AT THE NATIONAL HIGHWAY FRONTING KATANGAWAN ELEMENTARY SCHOOL, BARANGAY KATANGAWAN, THIS CITY, UPON WHICH A CITY GOVERNMENT-OWNED CONCRETE POLE AND ITS APPURTENANCES INCURRED DAMAGES FROM A PRIVATE VEHICLE BEARING PLATE NO, AAQ 6711 DRIVEN BY MR. GIL VALLEGA BERJES, JR. OF THE PHILIPPINE BRITISH ASSURANCE COMPANY, INC.

WHEREAS, the Deed of Quitclaim to be entered into by and between the City Government of General Santos, represented by the City Mayor, Honorable Ronnel C. Rivera, in favor of Philippine British Assurance Company, Inc. and Mr. Gil Vallega Berjes, Jr., consequential to an incident that happened last December 16, 2016, at around 5:50 AM at the National Highway in front of Katangawan Elementary School, Brgy. Katangawan, this city, particularly involving a private vehicle, a Ford Ranger bearing Plate No. AAQ 6711, driven by Mr. Gil Vallega Berjes, Jr. of this firm which caused damage to a concrete post with LED streetlight owned by the City Government of General Santos, in the amount of ₱ 44, 537.60;

WHEREAS, this subject accord is necessary in order to perfect the entitlement of insurance claim and for such other legal settlements relative to the same incident;

WHEREAS, this Sanggunian finds this Deed of Quitclaim in order pursuant to the provisions of Section 455, Paragraph (b)(1)(vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the City Mayor to represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod concerned pursuant to law or ordinance;

NOW, THEREFORE, on motion of City Councilor Jose Edmar J. Yumang, duly seconded by City Councilor _____, be it –

RESOLVED, as it is hereby resolved, to authorize the City Mayor, Honorable Ronnel C. Rivera, to enter into a Deed of Quitclaim in reference to the incident last December 16, 2016 at the National Highway Fronting Katangawan Elementary School, Barangay Katangawan, this city, upon which a City Government-Owned Concrete Pole and its appurtenances incurred damages from a Private Vehicle bearing Plate No. AAQ 6711 driven by Mr. Gil Vallega Berjes, Jr. of the Philippine British Assurance Company, Inc.
