RESOLUTION ALLOCATING AN AREA OF 2,555 SQUARE METERS WITHIN CAD. LOT. NO. 5749 SITUATED IN BARANGAY DADIANGAS EAST, GENERAL SANTOS CITY, FOR THE PURPOSE OF ESTABLISHMENT OF BUILDING FOR THE CITY HEALTH OFFICE

WHEREAS, SOMETIME ON DECEMBER 9, 1949, THE NATIONAL LAND SETTLEMENT ADMINISTRATION (NLSA) REPRESENTED BY ITS THEN MANAGER, ANTONIO D. PAGUIA EXECUTED A DEED OF SALE IN FAVOR OF THE MUNICIPALITY OF BUAYAN (NOW LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY), REPRESENTED BY ITS THEN CITY MAYOR, IRENEO SANTIAGO,

WHEREAS, THE SUBJECT DEED OF SALE, AMONG OTHERS, CONVEYED A PARCEL OF LAND, DENOMINATED AS FOLLOWS,

“f.Cad. Lot No. 5749;7.4633 Ha. in area; reserved as hospital site”

WHEREAS, SUCH DEED OF SALE ALSO STATES AMONG OTHERS, THAT “THIS SALE SHALL BE SUBJECT TO THE CONDITION THAT THE SAID LOTS SHALL ONLY BE USED FOR THE PURPOSE FOR WHICH THEY HAVE BEEN CONVEYED; OTHERWISE THE SAME SHALL REVERT TO THE CORPORATION,

WHEREAS, IN KEEPING WITH SUCH CONDITION, THE SANGGUNIANG PANLUNGSOD OF GENERAL SANTOS CITY DEEMS TO ALLOCATE AN AREA OF 2,555 SQUARE METERS WITHIN CAD. LOT NO. 5749 (WITH AN AREA OF 7.4633 Ha. RESERVED AS HOSPITAL SITE) FOR THE ESTABLISHMENT OF A BUILDING/STRUCTURE FOR THE USE OF THE CITY HEALTH OFFICE (CHO), WITH FUTURE ESTABLISHMENT OF A RURAL HEALTH UNIT AND/OR PRIMARY CARE FACILITY,
