RESOLUTION AFFIRMING THE VALIDITY OF RESOLUTION NO. 10, SERIES OF 2017, PASSED BY THE SANGGUNIANG BARANGAY OF LIGAYA, THIS CITY AUTHORIZING ITS PUNONG BARANGAY HON. ROMY M. PAGADUAN TO ACCEPT THE DONATION EXECUTED BY THE ROTARY CLUB REPRESENTED BY BAYANI ESTANISLAO, OF AN AREA PARTICULARLY DESCRIBED AS LOT 2204-E-2, (LRC) PSD-144975 AND LOT 2204-C-2, (LRC) PSD-144973 SITUATED IN THE BARRIO OF LAGAO (PRESENTLY BARANGAY LIGAYA), GENERAL SANTOS CITY INTENDED FOR BARANGAY HALL COMPOUND AND BARANGAY PLAZA (BARANGAY GYM) RESPECTIVELY

WHEREAS, for review of this *Sanggunian* pursuant to Paragraph (a)(1)(i), Section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991 is Resolution No. 10, Series of 2017, passed by the Sangguniang Barangay of Ligaya, this City, entitled:

"A Resolution Authorizing Barangay Captain Romy M. Pagaduan, Barangay Captain of Barangay Ligaya, General Santos City to Accept the Donation of Rotary Club represented by Bayani Estanislao such as: Lot 2204-E-2, (LRC) PSD-144975, situated in the Barrio of Lagao (presently Barangay Ligaya), General Santos City, containing an area of Two Thousand Eight Hundred Five (2,805) square meters, more or less and covered by Transfer Certificate of Title No. T-5536, issued by the Register of Deeds for the City of General Santos; Lot 2204-C-2, (LRC) PSD-144973 situated in the Barrio of Lagao (presently Barangay Ligaya), General Santos City, containing an area of Two Thousand Four Hundred (2,400) square meters, more or less and covered by Transfer Certificate of Title No. T-5533, issued by the Register of Deeds for the City of General Santos.

WHEREAS, after careful perusal of the provisions of the subject Barangay Resolution under review, this Sanggunian finds the same to be in order and, thereby, declares it to be within the prescribed powers of the Sangguniang Barangay to pass;

NOW, THEREFORE, on motion of City Councilor Jose Edmar J. Yumang, duly seconded by City Councilor _____, be it –

RESOLVED, as it is hereby resolved, Resolution Affirming the Validity of Resolution No. 10, Series of 2017, passed by the Sangguniang Barangay of Ligaya, this city authorizing its Punong Barangay Hon. Romy M. Pagaduan to accept the donation executed by the Rotary Club represented by Bayani Estanislao, of an area particularly described as Lot 2204-E-2, (LRC) PSD-144975 and Lot 2204-C-2, (LRC) PSD-144973 situated in the Barrio of Lagao (presently Barangay Ligaya), General Santos City intended for Barangay Hall Compound and Barangay Plaza (Barangay Gym) respectively.
