RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE RONNEL C. RIVERA TO ENTER INTO AN INTERNSHIP AGREEMENT WITH THE PUBLIC-PRIVATE PARTNERSHIP CENTER OF THE PHILIPPINES (PPP CENTER) FOR THE INTEGRATED ECONOMIC DEVELOPMENT FOR REGIONAL TRADE IN GENERAL SANTOS CITY

WHEREAS, this Internship Agreement to be entered into by the City Government of General Santos duly represented by its Mayor, Honorable Ronnel C. Rivera and the Public-Private Partnership Center of the Philippines duly represented by its Executive Director, Mr. Ferdinand A. Pecson, sets forth the terms and conditions relative to the Integrated Economic Development for Regional Trade in General Santos City;

WHEREAS, Resolution No. 535, Series of 2014 passed by the Sangguniang Panlungsod of General Santos approved the Integrated Economic Development for Regional Trade in General Santos City Project as a priority project to be implemented through any contractual agreement authorized under Republic Act (RA) 6957, as amended by RA No. 7718, or the "BOT Law" and its Implementing Rules and Regulations;

WHEREAS, the PPP Center is mandated under EO 8, Series of 2010, to:

- a) Conduct project facilitation and assistance to the national implementing agencies, including government corporations and Local Government Units (LGU) in addressing impediments or bottlenecks in the implementation of PPP programs and projects;
- b) Provide advisory services, technical assistance, trainings and capacity development to agencies/LGUs in PPP project preparation and development, among others. In its provisions for assistance to LGU programs and projects, the Center is implementing the Internship Program Strategy that adopts a learning-by-doing approach and expects to deliver projects development and roll outs support;

WHEREAS, the Redevelopment of Central Public Market and Queen Tuna Park is part of the Integrated Economic Development for Regional Trade in General Santos City Project, and to be prioritized by the General Santos City Public-Private Partnership Board;

WHEREAS, the City of General Santos acknowledges that it is the owner of the Project, and has requested the PPP Center to provide hands-on training and assistance to its key staff on project development and bid management;

WHEREAS, this Sanggunian finds the joint undertaking highly beneficial inasmuch as it will create a network of activities that can serve as an engine for economic development through providing opportunities for the incubation of small businesses, creating jobs in the local community, creating tourism and recreational area within the city, improving the local tourism industry and improving and revitalizing the local economy;

WHEREAS, this Sanggunian finds the subject MOA in order pursuant to the provisions of Section 455, Paragraph (b)(1)(vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the City Mayor to represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod concerned pursuant to law or ordinance;

NOW, THEREFORE, on motion of City Councilor Jose Edmar J. Yumang, duly seconded by City Councilor _____, be it –

RESOLVED, as it is hereby resolved, to authorize the City Mayor, Honorable Ronnel C. Rivera to enter into an Internship Agreement with the Public-Private Partnership Center of the Philippines for the Integrated Economic Development for Regional Trade in General Santos City.
