

RESOLUTION DECLARING SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2017 OF BARANGAY SIGUEL, THIS CITY IN THE AMOUNT OF ₱2,139,840.12 TO BE IN CONFORMITY WITH BOOK II, TITLE V OF THE LOCAL GOVERNMENT CODE OF 1991 AND OTHER APPLICABLE LAWS, RULES AND REGULATIONS

WHEREAS, endorsed to this Sanggunian for review is Supplemental Budget No. 01 for Calendar Year 2017 of Barangay Siguel, this city, in the amount of ₱2,139,840.12 with details as embodied in its Appropriation Ordinance No. 01, Series of 2017;

WHEREAS, Section 333 of R.A. 7160, otherwise known as the Local Government Code of 1991, confers power to the Sangguniang Panlungsod to review barangay budget to ensure that the provisions of the Code on Local Fiscal Administration are complied with, which review power includes the authority to declare the same inoperative if it is ascertained that the appropriations contained therein exceed the estimates of the income duly certified as collectibles, or that the same has not complied with the budgetary requirements set forth; and the authority to disallow the same if the items of appropriation are contrary to, or in excess of, any of the general limitations or the maximum amount prescribed;

WHEREAS, this Sanggunian finds that the aforesaid proposed Supplemental Budget has satisfactorily met the necessary budgetary requirements set forth under the Local Government Code of 1991, hence, declares the same budget operative in its entirety and effective in its stated date of effectivity, however, the said Sangguniang Barangay is directed to observe the following conditions:

1. The grant of Year-End Bonus and Cash Gift shall adhere to the provisions of Budget Circular No. 2016-4, dated April 28, 2016 of the Department of Budget and Management;
2. The grant of Productivity Enhancement Incentive (PEI) to Barangay Officials shall adhere to the provisions set under DBM Circular 2016-8, dated December 12, 2016;
3. The provisions of RA 9184 and its revised implementing rules and regulations in the procurement of goods shall be strictly adhered to;
4. Utilization of SK Fund shall be in accordance to Section 2 Rule 5 of the IRR of RA 10632;
5. Utilization of LDRRM Fund shall be in accordance with the guidelines set under Joint Circular No. 2013-1, dated March 25, 2013 of the Department of Interior and Local Government, Department of Budget and Management Council; and COA Circular No. 2012-002 dated September 12, 2012.
6. That the review does not authorize items that are prohibited by law.

WHEREAS, compliance with existing accounting and auditing rules and regulations shall be strictly observed in the implementation of this budget which shall be the responsibility of the Punong Barangay.

NOW, THEREFORE, on motion of City Councilor Franklin M. Gacal, Jr., duly seconded by City Councilors _____ and _____, be it -

RESOLVED, as it is hereby resolved, to declare Supplemental Budget No. 01 for Calendar Year 2017 of Barangay Siguel, this city in the amount of ₱2,139,840.12 to be in conformity with Book II, Title V of the Local Government Code of 1991 and other applicable laws, rules and regulations.
