**WHEREAS**, the Department of Environment and Natural Resources - Environment Management Bureau Region XII (DENR-EMB XII) thru its Regional Director, Ma. Socorro C. Lanto, signed a Memorandum of Agreement with the Local Government Units of General Santos City, Sultan Kudarat, Kidapawan, Alabel, Koronadal, Libungan, Cotabato, Tacurong and Polomolok held on July 21, 2017, Koronadal City for the establishment of Materials Recovery Facility (MRF);

**WHEREAS**, during the signing of Memorandum of Agreement (MOA), the Department of Environment and Natural Resources - Environment Management Bureau Region XII (DENR-EMB XII), granted a cash assistance of P200,000 (Two Hundred Thousand Pesos) to the city for the establishment Material Recover Facility (MRF) at the City Public Market;

**WHEREAS**, the grant of the cash assistance is in line with the intensification of RA 9003 otherwise known as The Ecological Solid Waste Management Act which mandates the establishment of Materials Recovery Facility (MRF) in every barangay or cluster of barangays in order to meet the mandatory waste diversion of solid waste from waste disposal facilities through re-use, recycling, and composting activities and other resource recovery activities;

**WHEREAS**, the establishment of the Material Recover Facility (MRF) at the City Public Market will strengthen proper segregation, collection, storage, and disposal of solid wastes which are vital to protect the public health and environment;
