The session started with a prayer song followed by the singing of the Philippine National Anthem and the General Santos City Hymn by the General Santos City Government Performing Arts Company–Choir Division. The session was then called to order at 9:17 o'clock in the morning with the Honorable City Vice-Mayor Shirlyn L. Bañas-Nogralas presiding. After the roll was called and there being a quorum, the chair thereupon declared the 51st regular session open for business.

G. PRIVILEGE HOUR:

The first speaker was Councilor Lourdes F. Casabuena. She proudly introduced Mr. Nelson Salangsang, born and bred in General Santos City and was her student at Mindanao State University, who is currently the manager of International Projects at Queensland University of Technology (QUT). He is an international development practitioner by profession specializing in capacity building, learning and development, and engagement. He has been permanently living in Queensland, Australia since 2001 and his visit is part of an Australian Awards Fellowship project with the Mindanao Development Authority (MINDA) and the Mindanao Business Council, focusing on building the capacity of Mindanao on international business for the agri-business sectors. On suspended rules, Mr. Salangsang together with Mr. Melvin Colin, Director of the Office of Commercial Services of QUT and Ms. Anelyn Binangilan, Director for Agri-Business Sector of MINDA, expounded on the concept of said endeavor and responded to queries posed by the members of the council. After some exchange of ideas, Councilor Casabuena concluded her availment of the privilege hour by thanking her invited guests for gracing the session. A photo opportunity with the guests followed. Thereafter, suspension of the rules was lifted.

Councilor Shandee Theresa O. Llido-Pestaño was the second speaker after her motion for reconsideration was granted. Her topic was focused on "WHAT IS HAPPENING TO OUR CHILDREN?" This has reference to the letter sent by the President of Golden State College asking for a legislative action or any means to deter minors, particularly students from engaging in drinking and smoking binges on establishments (like J'S STORE also known as UNIBERSIDAD DE NARANJITA) that have no regard on their moral obligations to these students but only after on gaining profits. After her presentation, it was resolved that a joint committee hearing will be conducted by the Committees on Social Services, Laws, Peace and Order, and Trade & Industry, to thresh out all the issues and concerns on this matter. It was resolved further to invite the owner of the establishment concerned, representative from the Permits and Licenses Division, PNP, CENRO and all other concerned agencies to the said joint hearing. They then proceeded to the next item.
