The committee hearing was called to order by its chairperson, City Councilor Alberto D. Pacquiao and afterwhich was the acknowledgment of everyone's presence.

When asked, Ms. Hannah Romulo, Budget Officer II, City Budget Office informed that the funding for the proposed project in the amount of ₱750,000.00 is chargeable against the 2017 Annual Budget.

Engr. Dexter De Castro, Engineer I from the City Engineer's Office, explained that the project will be composed of 2 comfort rooms for PWD (Male/Female), 2 comfort rooms (Male/Female), 3 shower rooms (Male), 3 shower rooms (Female) and lavatory (outside).

However, Brgy. Captain Veneracion stated that the barangay was not involved during the planning of this project. Since the Queen Tuna Park is under the jurisdiction of the city, his concern is on the maintenance of the rest rooms/shower rooms which are for public use, therefore, no fee will be extracted from the users.

Upon information of Engr. De Castro that it was Mr. Madria from CENRO who requested this project, Hon. Acharon manifested to invite him during the discussion on second reading in the plenary for everybody's clarification.

Thereafter, the chair ruled this item approved on committee level and to be calendared for second reading next regular session.
