The hearing was formally called to order by its chairperson, Honorable Shandee Theresa O. Llido-Pestaño to discuss the hereunder agendum.

**AGENDUM**

**SPPO NO. 1718-0152: AN ORDINANCE CREATING THE BARANGAY TOURISM COUNCIL FOR THE 26 BARANGAYS IN GENERAL SANTOS CITY. (Hon. Shandee Theresa O. Llido-Pestaño-Author/Sponsor).**

Upon discussing this item, the only sections which had amendments were the following:

Section 3. Creation and Composition of the Barangay Tourism Council and Membership.

Under letter "c". Members, the first bullet was changed to ***purok chairperson or president of the purok association of the purok chairman.*** She then clarified that this ordinance is still subject for further amendment.

When further inputs were solicited, another amendment was introduced in the same section that there should be ***one co-chairperson coming from the private sector.*** Upon motion filed by Kagawad Biñas of Barangay Dadiangas South, duly seconded, the chair ruled the amendment approved with the manifestation that the barangay secretary will serve as the BTC secretariat.

***APPROVED AS AMENDED, SUBJECT TO STYLE***

*Section 4. Meetings.*

*There was an added sentence after the first sentence to read as, "However, if maybe called to special meetings as the punong barangay deemed it necessary."*

***APPROVED AS AMENDED, SUBJECT TO STYLE***

At this juncture, an amendment by addition was introduced as ***Section 7. Term of Office.***

***AMENDMENT-APPROVED, SUBJECT TO STYLE***

Note: The numbering of the succeeding sections was adjusted accordingly so that the original section 7 shall now be section 8 as reflected below.

*Section 8. Funding.*

The first sentence was amended to read as: ***"Each barangay shall allocate sufficient funds from their Annual Internal Revenue Allotment share."***

***APPROVED AS AMENDED, SUBJECT TO STYLE***

Upon motion of Councilor Melliza, duly seconded, the chair ruled this item approved as amended to be calendared for second reading on Tuesday's regular session with the manifestation that Councilor Melliza is the co-author.

***APPROVED AS AMENDED ON COMMITTEE LEVEL-FOR SECOND READING***

There being no more matter to discuss, the chair declared the hearing adjourned at 3:05 in the afternoon.
