RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE RONNEL C. RIVERA TO ENTER INTO A DEED OF TRANSFER AND ACCEPTANCE (DOTA) WITH THE NATIONAL HOUSING AUTHORITY WITH REGARD TO THE COMPLETED MULTI-PURPOSE COVERED COURT LOCATED AT GUARDIANS' HILL AFP/PNP HOUSING PROJECT, PUROK UPPER LONDON, BARANGAY BAWING, GENERAL SANTOS CITY, IN FAVOR OF THE LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY

WHEREAS, for and in consideration of public service, the Deed of Transfer and Acceptance to be entered into by and between the City Government of General Santos, represented by the City Mayor, Honorable Ronnel C. Rivera, and National Housing Authority, duly represented by its Acting General Manager, Mr. Marcelino P. Escalada Jr., cedes, transfers and conveys to the City Government, by way of Deed of Transfer, the One Unit Multi-Purpose Covered Court Center in Guardians Hill AFP/PNP Housing Project, Purok Upper London, Barangay Bawing, this city;

WHEREAS, the National Housing Authority (NHA) under its Board Resolution Nos. 5314 dates March 29, 2011 and 5322 dated March 17, 2011 approved the implementation of the President's Housing Project for the AFP/PN Personnel which includes construction of various community facilities;

WHEREAS, the NHA has completed the construction of Php 6.029 Million One Unit Covered Court/ Multi-purpose Center in Guardians Hill AFP/PNP Housing Project using the Community Facilities Fund;

WHEREAS, the NHA under its Board Resolution No. 4115 dated May 27, 1999, was authorized by the Board to turn over the completed project components falling under the operation/maintenance of the City of General Santos;

WHEREAS, the City Government of General Santos City will utilize and maintain the completed One Unit Covered Court/Multi-Purpose Center in Guardians Hill AFP/PNP Housing Project, Barangay Bawing, this city for the physical and social development of the project beneficiaries and for the livelihood programs of the city;

WHEREAS, this Sanggunian finds the subject Deed of Transfer and Acceptance (DOTA) in order pursuant to the provisions of Section 455, Paragraph (b)(1)(vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the City Mayor to represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod concerned pursuant to law or ordinance;

NOW, THEREFORE, on motion of City Councilor Jose Edmar J. Yumang, duly seconded by City Councilor _____, be it –

RESOLVED, as it is hereby resolved, resolution authorizing the City Mayor, Honorable Ronnel C. Rivera to enter into a Deed of Transfer and Acceptance (DOTA) with the National Housing Authority with regard to the completed multi-purpose covered court located at Guardians' Hill AFP/PNP Housing Project, Purok Upper London, Barangay Bawing, General Santos City, in favor of the Local Government Unit of General Santos City.
