

RESOLUTION DECLARING SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2017 OF BARANGAY LAGAO, THIS CITY IN THE AMOUNT OF ₱7,329,392.03 TO BE IN CONFORMITY WITH BOOK II, TITLE V OF THE LOCAL GOVERNMENT CODE OF 1991 AND OTHER APPLICABLE LAWS, RULES AND REGULATIONS

WHEREAS, endorsed to this Sanggunian for review is Supplemental Budget No. 01 for Calendar Year 2017 of Barangay Lagao, this city, in the amount of ₱7,329,392.03 with details as embodied in its Appropriation Ordinance No. 02, Series of 2017;

WHEREAS, Section 333 of R.A. 7160, otherwise known as the Local Government Code of 1991, confers power to the Sangguniang Panlungsod to review barangay budget to ensure that the provisions of the Code on Local Fiscal Administration are complied with, which review power includes the authority to declare the same inoperative if it is ascertained that the appropriations contained therein exceed the estimates of the income duly certified as collectibles, or that the same has not complied with the budgetary requirements set forth; and the authority to disallow the same if the items of appropriation are contrary to, or in excess of, any of the general limitations or the maximum amount prescribed;

WHEREAS, this Sanggunian finds that the aforesaid proposed Supplemental Budget has satisfactorily met the necessary budgetary requirements set forth under the Local Government Code of 1991, hence, declares the same budget operative in its entirety and effective in its stated date of effectivity, however, the said Sangguniang Barangay is directed to observe the following conditions:

1. The granting of Salary Adjustment of barangay officials shall adhere to Local Budget Circular No. 113, dated January 5, 2017 issued by the Department of Budget and Management.
2. The provisions of RA 9184 and its implementing rules and regulations in the procurement of goods shall be strictly adhered to;
3. The review action does not authorize any item of appropriation that is prohibited by or inconsistent with the provisions of law.

WHEREAS, compliance with existing accounting and auditing rules and regulations shall be strictly observed in the implementation of this budget which shall be the responsibility of the Punong Barangay.

NOW, THEREFORE, on motion of City Councilor Franklin M. Gacal, Jr., duly seconded by City Councilors _____ and _____, be it -

RESOLVED, as it is hereby resolved, to declare Supplemental Budget No. 01 for Calendar Year 2017 of Barangay Lagao, this city in the amount of ₱7,329,392.03 to be in conformity with Book II, Title V of the Local Government Code of 1991 and other applicable laws, rules and regulations.
