WHEREAS, the amended Memorandum of Agreement (MOA) to be entered into by and between the Local Government Unit (LGU) of General Santos City represented by the City Mayor, Honorable Ronnel C. Rivera and Philippine Fisheries Development Authority represented by its Port Manager Mr. Luisito – Romeo M. Correa, defines the terms and conditions relative to the management of various events in celebration of Tuna Festival 2017;

WHEREAS, the Local Government Unit (LGU) of General Santos intends to implement the TUNA FESTIVAL 2017 in the City, with its festival funds amounting to Four Million Seven Hundred Thousand Pesos (Php 4,700,000.00);

WHEREAS, the Philippine Fisheries Development Authority applied for and was selected as the most qualified entity to manage the TUNA FESTIVAL 2017 and is willing to share an equity of Four Million Pesos (Php 4,000,000.00) totalling an estimated project cost of Eight Million Seven Hundred Thousand Pesos (Php 8,700,000.00);

WHEREAS, the TUNA FESTIVAL 2017 is a major event celebrating the city's bounty of the sea and to pay tribute to the fisherfolks responsible for the City's tagline as the Tuna Capital of the Philippines which has greatly benefit the GENERALS by showcasing its prime industry building positive image of the city, thus, increase the influx of visitors and promote entrepreneurship while providing sustainable livelihood opportunities and jobs;

WHEREAS, this Sanggunian finds the subject Memorandum of Agreement (MOA) in order pursuant to the provisions of Section 455, Paragraph (b)(1)(vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the City Mayor to represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod concerned pursuant to law or ordinance;
