RESOLUTION AFFIRMING THE VALIDITY OF BARANGAY RESOLUTION NO. 30, SERIES OF 2017, PASSED BY THE SANGGUNIANG BARANGAY OF BULA, THIS CITY, ADOPTING EXECUTIVE ORDER NO. 07 SERIES OF 2017, ISSUED BY PRESIDENT RODRIGO R. DUTERTE, TEMPORARILY SUSPENDING THE ISSUANCE OF PERMITS TO ALL ACTIVITIES OF THE PUROK/ZONE OF BARANGAY BULA

WHEREAS, for review of this Sanggunian pursuant to Paragraph (a)(1)(i), Section 458 of Republic Act 7160, otherwise known as the "Local Government Code of 1991", is Barangay Resolution No. 30 series of 2017, passed by the Sangguniang Barangay of Bula entitled:

"A RESOLUTION ADOPTING EXECUTIVE ORDER NO.07, SERIES OF 2017 DATED 02 JUNE 2017, "AN EXECUTIVE ORDER TEMPORARILY SUSPENDING THE ISSUANCE OF PERMITS TO ALL ACTIVITIES OF THE PUROK/ZONE OF LGU-BARANGAY BULA, GENERAL SANTOS CITY IN RELATION TO THEIR FIESTAS AND ANNIVERSARIES FOR SAFETY REASONS AND PROVIDING RULES AND GUIDELINES FOR THE PROTECTION OF ITS INHABITANTS PENDING THE LIFTING OF PRESIDENTIAL PROCLAMATION NO.216, SERIES OF 2017 DECLARING A STATE OF MARTIAL LAW AND SUSPENDING THE PRIVILEGE OF THE WRIT OF HABEAS CORPUS IN THE WHOLE OF MINDANAO".
