WHEREAS, the Sarangani Province Values and Spiritual Transformation Association has applied for accreditation with the City Government of General Santos, pursuant to Republic Act 7160, otherwise known as the Local Government Code of 1991 and Department of the Interior and Local Government (DILG) Memorandum Circular No. 2010-73;

WHEREAS, Section 34 of the aforesaid Code provides that local government units shall promote the establishment and operation of people's organizations and non-government organizations to become active partners in the pursuit of local autonomy;

WHEREAS, Article 64 of the Implementing Rules and Regulations of the same Code lays down the procedure and guidelines for the selection of representatives of POs, NGOs or private sectors in Local Special Bodies;

WHEREAS, DILG Memorandum Circular No. 2010-73 further provides, among others, clarificatory guidelines relative to the accreditation of POs, NGOs, and other organized groups whether previously accredited or seeking accreditation for the first time, and as such, correspondingly stipulates the proper selection of their representatives to the Local Special Bodies;

WHEREAS, accrediting this organization is a way of ensuring viability of local autonomy as an alternative strategy for sustainable development;
